The Central Board of Secondary Education (CBSE) is going to conduct the Direct Recruitment Quota Examination 2026 (DRQ2026) in accordance with Advertisement No. CBSE/Rectt.Cell/14(88)/2025 dated 02<sup>nd</sup> December 2025.

After the closing date for receipt of online applications, i.e., 27<sup>th</sup> December 2025 (11:59 PM), candidates will be provided a two-day edit window, as per the schedule given below, to enable candidates to correct or modify any incorrect particulars filled by them in the online application form.

#### Important Instructions:

- Only those candidates who have **successfully submitted their completed online application form along with payment of the requisite fees** within the stipulated period of application registration will be allowed to make corrections.
- This is a **one-time facility** provided to candidates to avoid hardship. Candidates are therefore advised to make corrections **very carefully**, as **no further opportunity for correction will be provided**. The details are as follows:
