Subject: Declaration of results of UGC-NET June 2026 - reg.

1. The UGC-NET June 2026 examination was conducted by the National Testing Agency (NTA) in CBT mode on 22, 23, 24, 25, 29, 30 June 2026 and 05 July 2026 across 655 examination centres in 286 cities in 87 subjects across the country.
2. In respect of three subjects, namely *English, Commerce and Sociology*, NTA shall be re-conducting the examination for these subjects on 09 September 2026 and 10 September 2026. (Please refer to the public notice dated 16th August 2026 in this regard for details)

The Question Paper, Provisional Answer Key(s) and Recorded Responses of the concerned candidates for the 84 subjects of UGC-NET June 2026 Examination were hosted on the NTA website <https://ugcnet.nta.nic.in/> from 16th August 2026 to 18th August 2026 to invite challenges. Challenges received were verified by the experts and results were processed as per the answer keys finalized by experts.
5. The result of UGC-NET June 2026 examination for 84 subjects is being declared today i.e. 28.08.2026. Result at a Glance is as follows:

The scorecard/result for these candidates will be made available ONLY after the re-conduct of their examination.
7. **Important Note:** The eligibility criteria, self-declaration, various documents, etc. of the eligible candidates shall be verified as per norms specified in the information bulletin of UGC-NET June 2026 by the concerned authorities as per the due process.
